**JOINT MOTION FOR FINAL APPROVAL
AND ENTRY OF PERMANENT INJUNCTION**

Pursuant to Practice Book § 17-1 and Conn. Gen. Stat. § 3-125a, the undersigned hereby respectfully move the Court to enter final approval and Final Judgment of Permanent Injunction in this matter in accordance with this motion.

In support of this motion, the undersigned jointly represent as follows:

1. On January 27, 2022, this Court entered the following order: “The court preliminarily approves this motion for permanent injunctive relief and awaits further approval by the legislature to enter the permanent injunction.”
2. Thereafter, in accordance with Conn. Gen. Stat § 3-125a, the Attorney General submitted the underlying settlement agreement in this matter to the General Assembly on February 15, 2022, as shown by the attached Exhibits 1 and 2.
3. Section 3-125a provides, in relevant part, that “[s]uch provision shall be deemed approved if the General Assembly fails to vote to approve or reject such provision within 30 days of the date of submittal [to the General Assembly].”
4. The General Assembly has failed to vote to approve or reject such provision within 30 days of submittal.

WHEREFORE, the parties move this court to enter final approval and Final Judgment of Permanent Injunction in this matter In accordance with the Permanent Injunction filed in this matter on January 27, 2022.
