



## Fighting for the legal rights of Connecticut's most vulnerable children.

With February well underway, the Center for Children's Advocacy (CCA) is advocating for legislative reforms to enforce the rights of children to health, safety, and education, and fighting for resources to ensure children's basic needs are met. This newsletter outlines our legislative agenda in detail, highlights our recent work on behalf of immigrant youth, youth with disabilities, and youth experiencing homelessness, provides vital information on the housing rights of displaced tenants, and celebrates our community partners and supporters.

### 2026 Legislative Priorities


Every day, CCA advocates for individual children and families navigating complex legal and social systems. And our work does not stop with individual cases.

We also focus on strengthening and transforming the systems that shape children's lives across Connecticut.

During the 2026 legislative session (February 4–May 6, 2026), CCA is advancing policy priorities aimed at protecting children's health and safety, enforcing their civil rights, and ensuring that no young person exits state care into homelessness.

This session, alongside other advocacy efforts, our work centers on four urgent areas: a child welfare system in crisis, ensuring access to early intervention services for children ages birth to three, the rights and safety of students with disabilities, and preventing homelessness for young people transitioning out of state agency care.

## Black History Month Spotlight:

### Improving Care for Youth in Chronic Pain

During Black History Month, CCA is supporting youth-led advocacy at the intersection of racial equity, health justice, and disability rights. Through our Hartford Medical Legal Partnership Project, CCA partnered with Connecticut Children's Medical Center's Chronic Pain Advocacy Group (CPAG) to develop legal content for its new **Voices 4 Youth in Pain** website, <https://voices4youthpain.org>. The CPAG is a group of teens and young adults of color who experience chronic pain, and their caregivers.

The site responds directly to a reality too often faced by Black youth: pain complaints dismissed, minimized, or misunderstood in schools and some healthcare settings. By centering lived experience and legal rights, Voices 4 Youth in Pain empowers families with tools to advocate for appropriate care, educational accommodations, and dignity.

## CCA's Immigration Advocacy

A 17-year-old high school student was held in U.S. Immigration and Customs Enforcement (ICE) custody in Connecticut for nearly four months – despite living lawfully with his father and attending school – after being detained during a routine stop in New York.

With legal action and advocacy from Sabrina Tavi, CCA's Director of the Immigrant Children's Justice Project, and CCA Board Member Christopher Mattei of Koskoff Koskoff & Bieder PC, a federal judge ordered the youth's release, allowing him to reunite with his father just days before the holidays.

## Advocating for Systemic Change in Schools

In a recent Op-Ed for the CT Examiner, Kathryn Meyer, Director of CCA's Medical-Legal Partnership at Yale Child Study Center, Zoe Masters, Staff Attorney with CCA's School Justice Project, and Dan Pearson, Executive Director of Educators for Excellence, argue that rising challenges in schools are not the result of student behavior alone, but of systemic conditions that deprive children and teachers of the tools they need to support and educate children.

This 2026 legislative session, CCA is advancing policy priorities informed by these challenges and focused on investing in student supports, strengthening school-based services, and addressing the root causes shaping student outcomes.

## Uniform Relocation Assistance Act: Know Your Rights

**DID YOU KNOW?** The Uniform Relocation Assistance Act (URAA) requires cities and towns to provide relocation assistance to residents who are displaced by a fire or condemnation of an uninhabitable apartment, including help paying for short-term housing and deposits for an apartment. Every city and town in CT must provide URAA rights, including payments up to \$4000.

CCA's Medical Legal Partnership (MLP) at Yale New Haven Hospital recently learned that the City of Bridgeport was not complying with the URAA, specifically after fires that made units uninhabitable. The MLP is connected to partners at CT Legal Services and CT Fair Housing, who will ensure Bridgeport provides assistance to all eligible families, and MLP continues to assist people who are not receiving their URAA rights.

## CCA's Youth Homelessness Advocacy

CCA recently partnered with the CT Judicial Branch's Court Support Services Division (CSSD) to present Connecticut's collaborative work addressing housing instability and youth homelessness within the justice system to a national audience.

The presentation, delivered to grantees of the Youth Homelessness System Improvement Program, highlighted CCA and CSSD's joint efforts to develop and administer a housing survey for minors and youth entering and exiting the justice system, build a case-conferencing model for youth experiencing housing instability or homelessness, and implement housing-focused interventions informed by shared data.
